### V. Potential update to Bylaws surrounding the election:

#### ARTICLE V: OFFICERS AND THEIR ELECTION

#### Section 3. Nominating Committee

a. There shall be a nominating committee composed of five members: the Arts Education Liaison and an additional member of the executive board, and three persons from the general membership, nominated by the executive board and elected by the organization at a regular meeting in February. The committee shall elect its own chairperson. The president shall not serve on this committee.

- b. The nominating committee shall nominate one (1) eligible person for each office to be filled, and reports its nominees at the regular meeting in April. Additional nominations may be made from the floor, prior to the election, at the May meeting.
- c. Only those persons who have signified their consent to serve, if elected, shall be nominated for or elected to such offices.
- d. No member shall hold more than one office at a time, unless specified in these bylaws (i.e. 1<sup>st</sup> Vice President Ways & Means chairperson).
- e. The nominating committee shall be provided a current membership roster at their election in February.
- f. Articles VI: Duties of Officers should be read by a member of the Nominating Committee to all nominees prior to elections.
